Bi-Laws/Policies Update (Master Orlando in absentia): Operating and Financial policy changes have been sent to Kingdom for initial review. They will be posted by this weekend for review by the Shire. After a 30 day comment period we will vote on whether or not to adopt the policies as presented. This is why we are pushing November's meeting, so we can meet that 30 day comment period. Comments should be sent to myself and Master Orlando. We will need Quorum at November's meeting.

Overview of changes to operating policies: changing "by-laws" to "operating policies," inclusive language, election timeline to allow for transition time, clarified line of authority for Officers, transition of property, official communication channel, changing quorum to 5 (from 10), give seneschal authority to cancel meetings, making more use of website to house shire information, clarify amendment process.

Overview of changes to Financial Policies: changing date for budget, reporting year end findings to Shire, removed redundancies, removed preferred dates for specific events.

Official Communication Channel Discussion: Think about what the Shire might want. Leaning toward website, but open to discussion.
